UPDATE ON RECYCLING PROJECT

Gail Vanderbrink from the City's Community Liaison Office responded to our article in the summer newsletter. The city itself is starting a recycling program in neighborhoods that show at least 30% of the households wish to participate. After a discussion at the last board meeting, it was decided to ask the city instead to consider placing a drop off box at a central location in the neighborhood, such as the Scout House, so that problems of scheduling and accumulation will be minimized. Ms. Vanderbrink has promised to look into this option and will be getting back in touch with the board at a later time. Until then, there is an option for those of you interested in recycling your newspapers. Box, bag, tie or in some way secure them and drop them in the box located in the back driveway of Hartsfield School. 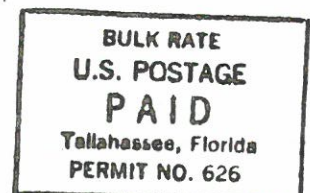
